 SUBJECT: PRELIMINARY Report #4 -- 2008 Pacific Whiting Fishery

This report consolidates preliminary state, federal, and tribal data for the 2008 Pacific whiting fishery. Due to concerns about the incidental catch of overfished species, bycatch limits are in place in the non-tribal sectors of the fishery for canary (4.7 mt), darkblotched (40 mt) and widow rockfish (275 mt). If any of the bycatch limits is reached, the primary whiting seasons for the non-tribal fisheries will end regardless of the amount of whiting allocation remaining.
